<b>Content</b>	<p>To respond to the fast changes of technology in the digital era, this module invites students to discuss the intersection of technology, abuse, and policies. Although technology has made life easier and convenient in many ways, it has also made it possible for new forms of abuse known as Technology-Facilitated Gender-Based Violence (TFGBV). Students that complete this course will have the knowledge on TFGBV, including its manifestations, impacts, and appropriate responses.</p> <p>The course emphasises the importance of survivor-centered, and ethically responsible data practices by looking through the lens of trauma-informed, and culturally sensitive interventions. The curriculum also examines the accountability of tech companies for mitigating and reducing abuse on their platforms.
